In addition, Residents **MUST** display the annual Ridgewood Resident Parking Sticker on the passenger window located behind the driver. The permit holder agrees to park **ONLY** in the designated parking spot in the preselected location. The undersigned agrees that the Village of Ridgewood will not be liable for any loss or damage to the above described motor vehicle, its equipment, and its contents occurring while said vehicle is parked in the Village.

If the applicant is not the owner of the vehicle described above, he/she represents that this application is made with the knowledge and consent of the owner and that the owner is bound by the provisions hereof.

I understand the provisions of the Ridgewood Central Business District 24/7/365 Parking Permit, including the requirements to properly hang the permit placard from the rearview mirror when parked and to remove it before driving. I agree that the Village of Ridgewood, the Ridgewood Parking Utility, as well as its employees, shall not be held liable for any loss or damage to me, my guests, anyone else or to the above described vehicle, its equipment or its contents, occurring while said vehicle is parked in the Hudson Street Garage or in the Cottage Place Lot, even if such personal injury or property damage is caused by negligence, actions, and/or inactions of the Ridgewood Parking Utility, its employees, or the Village of Ridgewood. I agree to hold the Ridgewood Parking Utility, its employees, and the Village of Ridgewood harmless for any such claims.
